PreFab Decks LLC / Three-Year Limited Warranty Valid on decks, garages, carports, and porches.

PreFab Decks LLC warrants to the original purchaser that your PreFab Decks LLC product is free from defects in material or workmanship upon delivery, and will repair or replace any components that do not provide reasonable service under normal use, for a period of three (3) years from the date of purchase. Correction by repair or replacement of materials or workmanship in your PreFab Decks LLC product, which our examination shall disclose to our satisfaction to be defective, shall constitute fulfillment of all liabilities of PreFab Decks LLC under this warranty. In order for this warranty to be valid, all exposed surfaces must be sealed within 3 months of purchase. All exposed surfaces must also be resealed every 12 months (proof of sealer purchase required) and properly maintained. PreFab Decks LLC shall not be liable for any installation or re-installation costs or for the natural characteristic of some wood to split, warp, or twist. The warranty printed above is the only warranty applicable to this purchase. ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE HEREBY DISCLAIMED. PreFab Decks LLC SHALL HAVE NO LIABILITY FOR PUNITIVE, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING BUT NOT LIMITED TO DAMAGES TO CONTENTS OF YOUR PreFab Decks LLC PRODUCT AND LOST PROFITS.
